ANNUAL ABATEMENT ORDINANCE

ORDINANCE NO. 2020-002

ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE YEAR 2020 TO PAY THE PRINCIPAL OF AND INTEREST ON GENERAL OBLIGATION BONDS, SERIES 2013, OF THE SIX MILE REGIONAL LIBRARY DISTRICT

WHEREAS, the Board of Trustees (the "Board") of the Six Mile Regional Library District (the "District"), by Ordinance Number 2013-04, adopted on May 14, 2013 (the "Bond Ordinance"), did provide for the issue of \$1,680,000 aggregate principal amount of General Obligation Bonds, Series 2013 (the "Bonds"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS, the District has determined that sufficient funds are legally available for the payment of the principal of and interest on the Bonds for the next bond year; and

WHEREAS, it is necessary and in the best interests of the District that the tax heretofore levied for the year 2020 to pay the principal of and interest on the Bonds be abated;

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE SIX MILE REGIONAL LIBRARY DISTRICT, AS FOLLOWS:

- **Section 1. Abatement of Tax.** The tax heretofore levied for the year 2020 in the Bond Ordinance is hereby abated in its entirety.
- **Section 2. Filing of Ordinance.** Forthwith upon the adoption of this ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerk of the County of Madison, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2020 in accordance with the provisions hereof.
- **Section 3. Effective Date.** This ordinance shall be in full force and effect forthwith upon its passage by the Board.
